- New Business: Debt Service Discussion Finance Director Christa Byrd presented the committee with Debt Service Principal Payment Impact on a note held by Federal Capital. She compared the principal and interest rates from two perspectives: 1) continuing to pay the note through 2019-20, which would yield a \$20,965.31 total interest payment or 2) to pay \$80,000 in principal this year in order to lower the interest payout over the life of the note to \$9,969.83. By selecting the second option, the savings to the citizens of Carter County would be \$10,995.48. L.C. Tester made the motion to select the second option and pay \$80,000 toward the principal. John Lewis seconded the motion and Chair Culler called for a roll call vote.

• County Medical Insurance Renewal: Director Byrd presented the committee with the past medical insurance history (2013-16; and the new projection for 2016-17) with Blue Cross/Blue Shield of Tennessee (BCBST). The rate changes have varied from 0% (2014-14) to 13.65% (2015-16). The rate for 2016-17 is an increase over the previous year by 8.65% or \$1,801,400. John Lewis expressed his opinion that the plan should be sent to the county's broker for a rate request from other companies. Several on the committee expressed that county employees are satisfied with BCBST and it would possibly mean changing providers and other issues that could result in a higher cost for employees. L.C. Tester made the motion to remain with BCBST and accept the percent increase. The motion was seconded by Al Meehan. Chair Culler called for a roll call vote.
