Commissioner L. C. Tester offered a prayer for all of our military families giving thanks to them for the freedom we have because of their sacrifices.

On motion by Jerry Pearman, seconded by Robert Davis, the minutes of the October 20, 2008, County Commission were approved by voice roll call vote.

L. C. Tester recognized Judge Robert Cupp who addressed the Commiss regarding the lack of adequate parking at the Courthouse Annex and Jail during the construction of the new jail. He stated that it was umfair to the employees at the Annex to have to search for a place to park. He furt stated that if an elderly or handicapped person should get injured trying to get to Court, the County would have a lawsuit on its hands. Jack Buckl stated that once the jail is complete parking will not be a problem. He said that the Commissioners had tried to alleviate the current problem but their hands were tied. He said that the City would not allow parking on their property at the ball field and had demanded that a fence be put up. When asked if he had a solution to the problem, Judge Cupp stated that he did not and that it was up to the Commissioners to fix the problem.

Under Public Comments, Wanda Markham told the Commissioners that she had repeatedly requested the Sheriff to investigate thefts on her property and he had made comments to her unbecoming of an elected official. Roy Livingston questioned the lack of accountability as to where the money went when it had been added to the tax rolls and earmarked for a certain contract when that contract was complete.

Don Hurst, President of Carter County Tomorrow, introduced the new Elizabethton/Carter County Chamber of Commerce Director Candy Craig. He commented on the Three Star Program stating that the county needed a land-use transportation plan in place to bring the county up to a Level Three community from its present Level One. He stated that a Level Three community had a better chance of scoring grant funds and attracting business and industrial prospects. Gebe Ritchie questioned Mr. Hurst about the five-year tax break that was given to Infinity Spas stating that because the tax break was negoiated without the approval of the Commissioners somebody owed the County \$45,000 in back taxes now that it was closed. Hurst stated that the Industrial Commission had the right to grant a tax break to a company. His statement was disputed by Commissioner Ritchie and he asked the County Attorney for his opinion. Mr. Bowers said he would do some research and set back to him

Jim Whaley, reporting for the Rules/By Laws Committee, stated that at the request of this committee he and Jerome Kitchens had met with Tom and Linda Whitehead, owners of the Carter on Main Restaurant. At this time Mr. Armstrong told the Commissioners that the Landfill did not have enough money to continue operations until the end of the year. The Budget Committee recommended that this matter be presented to the full Commission without any recommendation from them. Jerome Kitchens explained that due to a recent equipment repairs, fuel prices and less revenue than expected a cash flow problem had occurred. He said that there were three options to alleviate the problem short term. These were (1) making a loan to the Solid Waste Fund from the General Fund to be paid back over a period of time; (2) transferring funds to the Solid Waste Fund to get them by this year; or (3) shutting down the Landfill operations to a certain degree.

Motion was made by Jim Whaley, seconded by Nancy Brown to turn this matter over to the Landfill Committee to come up with a solution as soon as possible The drawback to this motion as discussed was that the next Commission meeting was not until January 2009 and the Landfill would most likely be out of money by the end of November forcing it to shut down. This would result in the loss of customers who would find another site to use. Mr. Whaley withdrew his previous motion and made the motion for this matter to be referred to the Landfill Committee and this Commission meeting be recessed to be called back when they had come up with a solution. After more discussion, Mr. Whaley amended his motion to state that a short term loan of \$25,000 be made to the Solid Waste Fund to get them through this present crisis and the matter be turned over to the Landfill Committee for future solutions.
