Livingston addressed the Commission and once again accused Mayor Holder and other county officials of withholding public records and shuffling money around Mr. Livingston's comments prompted a response from Finance and losing it. Director Jerome Kitchens who stated that the auditors had tried to explain to Mr. Livingston that no money was missing but he failed tounderstand. Mr. Kitchen went on to say that if the public repeatedly heard these negative comments that some people would probably believe them. He apologized if he was thought to be out of place but stated that he was tired of the public being told that money was missing and stated emphatically, "There is no money missing". Several Butler residents addressed the Commission opposing the actions of Cove Ridge Marina in building an RV campground on the marina property. They claimed that building the campground was in violation of county zoning Pat Middleton asked the county to produce the records proving that the marina was not in violation of any ordinances as the planning board was unable to produce such records. Jim Dabbondanza related that their main complaint was that barbed wire fences had been placed along residents' property lines but no required buffers.

RESOLUTION FIXING THE TAX LEVY IN CARTER COUNTY, TENNESSEE, FOR THE FISCAL YEAR BEGINNING JULY 1, 2009 (2009-2010)

SECTION 1. BE IT RESOLVED by the County Commissioners of Carter County, Tennessee, assembled in Elizabethton, Tennessee, at the Courthouse on the 27th day of July, 2009, that the combined property tax rate of Carter County Tennessee, for the fiscal year beginning July 1, 2009, and ending June 30, 2010, shall be \$2.28 on each \$100.00 of taxable property, both real and personal property, which is to provide revenue for each of the following funds and otherwise conform to the following levies;

\$ 0.960 General Purpose/Schools County General Fund \$ 0.798 \$ 0.420 Debt Service \$ 0.102 County Road Fund \$ 2.280 Total

SECTION 2. BE IT FURTHER RESOLVED that all resolutions of the County Commission of Carter County, Tennessee, which are in conflict with this Resolution are hereby repealed.

SECTION 3. BE IT FURTHER RESOLVED, that the budget for the School Federal Projects fund shall be the budget approved for separate projects within the fund by the Board of Education

<u>SECTION 2</u>. BE IT FURTHER RESOLVED, that there are also hereby appropriated certain portions of the Commissioners and fees for collecting taxes and licenses and for administering other funds which Trustee, County Clerk, Circuit Court Clerk, Clerk and Master, Register, and the Sheriff and their officially authorized by existing law or by valid order of any fees collected over and above the expenditures duly and conclusively authorized shall be paid over to the Trustee and converted into the General Fund as provided by law.

BE IT FURTHER RESOLVED, that if any fee officials, as enumerated in Section 8-22-101, T.C.A., operate under provisions of Section 8-22-104, T.C.A., provision of the preceding paragraph shall not apply to those particular officials.

<u>SECTION 3</u>. BE IT FURTHER RESOLVED, that any amendment to the budget shall be approved as provided in Section 5-9-407, T.C.A.

One copy of each amendment shall be filled with the County Clerk, one copy with the Chairman of the Budget Committee, and one copy with each divisional or departmental head concerned. The reason(s) for each transfer shall be clearly stated; however, this section shall in no case whatsoever be construed as authorizing transfer from one fund to another, but shall apply solely to transfers within a certain fund.

SECTION 4. BE IT FURTHER RESOLVED, that any appropriations made by this resolution which cover the same purpose for which a specific appropriation is made by statue is made in lieu of but not in addition to said statutory appropriation. The salary, wages, or remuneration of each officer, employee, or agent of the County shall not be in excess of the amounts authorized by existing law or as set forth in the estimate of expenditures which accompanies this resolution. Provided, however, that remuneration hereby authorized shall in no can be construed as permitting expenditure for an office, agency, institution, division or department of the County. Such appropriation,

shall constitute the limit to the expenditures for any office, agency, institution, division or department for the year ending June 30, 2010. The aggregate expenditures for any item of appropriation shall in no instance be more than the amount herein appropriated for such item.

SECTION 5. BE IT FURTHER RESOLVED, that any resolution which may hereafter be presented to the Board of County Commissions providing for appropriation in addition to those made by this Budget Appropriation Resolution shall specifically provide sufficient revenue or other funds, actually to the provided during the year in which the expenditure is to be made to meet such additional appropriation. Said appropriating resolution shall be submitted to and approved by State Director of Local Finance after its adoption as provided by Section 9-21-403, T.C.A.

SECTION 6. BE IT FURTHER RESOLVED, that the County Mayor and County Clerk are hereby authorized to borrow money on revenue anticipation notes provided such notes are first approved by the Director of Local Finance to pay expenses herein authorized until taxes and other revenue for the year 2009-2010 have been collected. The proceeds of loans for each of individual fund shall not exceed 60% of the appropriations of each individual fund and shall be used only to pay the expenses and other requirements of the fund for which the money is borrowed.

The loan shall be paid out of revenue from the fund for which shall be issued under the applicable sections of Title 9, Chapter 21, Tennessee Code Annotated. Said notes shall be signed by the County Mayor and countersigned by the County Clerk and shall mature and be paid in full without renewal not later than June 30, 2010.

SECTION 7. BE IT FURTHER RESOLVED, that the delinquent County property taxes for the year 2007 and prior years and the interests and penalty thereon collected during the year ending June 30, 2010 shall be apportioned to the various County funds according to the subdivision of the tax levy for the year 2009. The Clerk and Masters and the Trustee are hereby authorized and directed to make such apportionment accordingly.

SECTION 8. BE IT FURTHER RESOLVED, that all encumbered balances of appropriations remaining at the end of the year shall lapse, and be of no further effect at the end of the year at June 30, 2010.

<u>SECTION 9.</u> BE IT FURTHER RESOLVED, that any resolution or part of a resolution which has heretofore been passed by the Board of Commissioners which is in conflict with any provision in this resolution be and the same is hereby repealed.

SECTION 10. BE IT FURTHER RESOLVED, that this resolution shall take effect from and after its passage and its provisions shall be in force from and after July 1, 2009 This resolution shall be spread upon the minutes of the Board of County Commissioners.
